C Space-\$125 High Visibility. "Main Gate" Center Section on the hill., 10 ft open frontage and approximate 10ft depth, with shared inner space.

D Space- \$125 High Visibility. Perimeter Space Outside Open Ground space: 10' frontage and approximate 10ft depth. \$15/ foot Additional Footage.

***You must provide your own tent

***Extension cords are not provided for electric hook up. Vendors must bring this own.

***Include all tent stakes, ropes, trailer hitches etc. figuring your total frontage requirements.

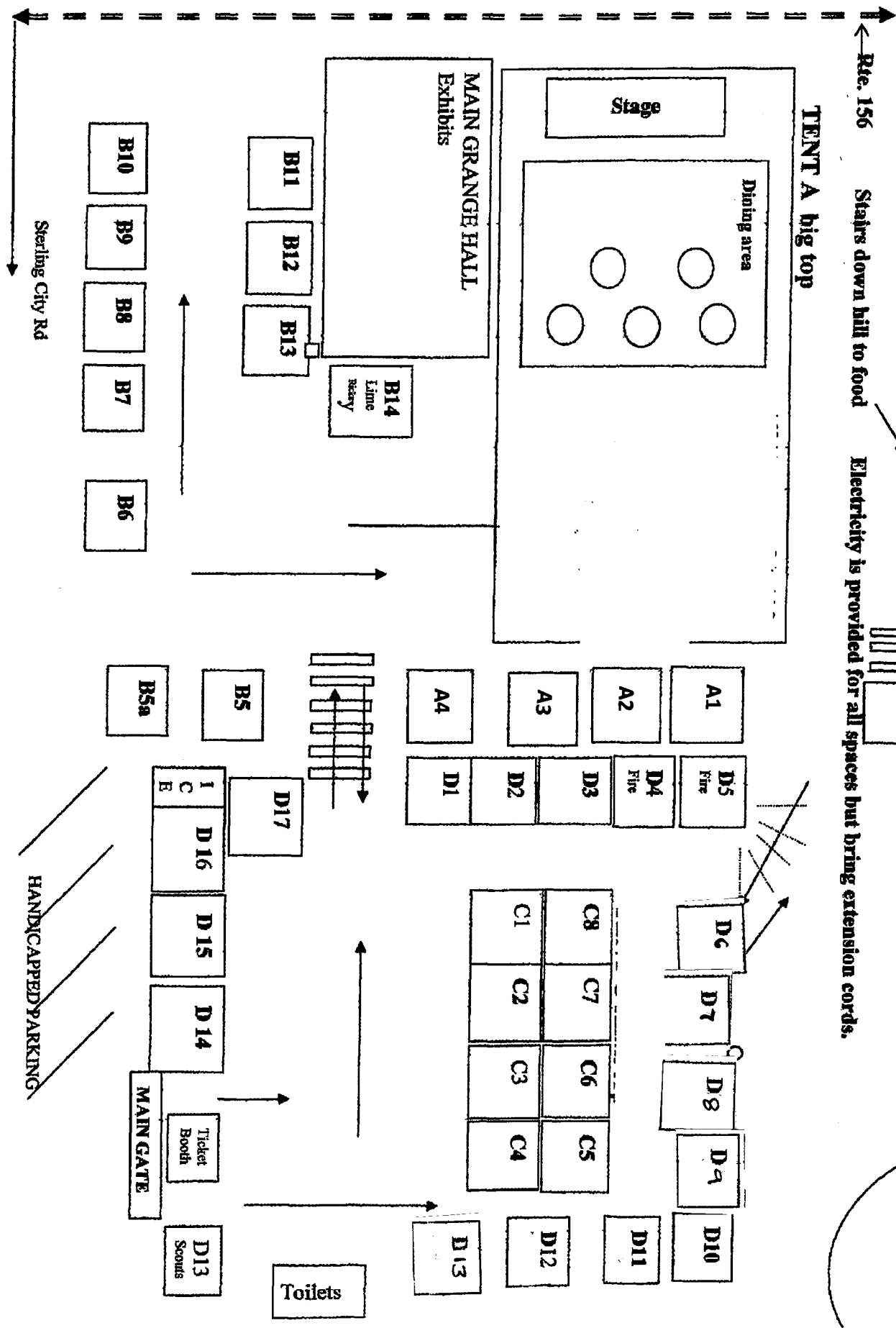

Rules and Regulations for Concessionaires and Exhibitors

1. No refunds are given after final payment has been made. Final Payment Due August 1.
2. Sharing of space is not allowed.
3. All spaces are priced by location.
4. Final location of all vendors within equally priced spaces is left up to the discretion of Fair Association. Upon final receipt of payment you will be mailed a map detailing space assigned.
5. A list of items to be sold must be submitted *with* deposit for approval prior to space approval. Any items other than those stipulated and approved in writing may not be sold. The Grange reserves the right to restrict or prohibit the sale or exhibiting of anything it deems to be dangerous, flammable, illegal or otherwise objectionable.
6. Booths must operate the entire length of the fair and cannot be shut down any earlier than closing time each night with the risk of forfeiting space the following year.
7. Space must be completely setup prior to fair opening each day.
8. Each concession is allowed 2 entry passes per day. Passes will be mailed to applicant.
9. No parking on fair grounds is allowed during fair hours. We will have special parking for large trailers. Car parking is available at the church or auto dealer across the street
10. No pets allowed on fair grounds.
11. The Fair Association is not responsible for items left on grounds. Your stock and materials are left at your own risk.
12. Please make the Fair Association aware of any special requirements you may need to operate your booth upon final payment.

****Sleeping overnight on Fair grounds is forbidden. Alcoholic beverages cannot be brought on Fair grounds. Violation of these rules will result in immediate expulsion from the fair and the forfeit of all fees paid.**
